

**2.1 To confirm the proceedings of last meeting**

Controller of Examination Mr.S.A.Shinde proposed the proceedings of last meeting held on 2<sup>nd</sup> February 2026. He read out agenda and minutes of meeting.

**2.2 To Prepare Examination Calendar for the second term (2025-26)**

It was also discussed to make compulsion of uniform along with college ID and hall ticket.
