## Agenda. 1.1. To confirm the minutes of the last meeting

**Explanation:** Dr. M.M. Rajmane, Principal & Ex Officio read the proceedings agendum-wise of the Last Governing Body meeting held on 17 May 2024 at 5:00 pm and brought to the notice of the house that the resolutions made therein have been executed during the first half of the year. He elaborated on the issues considered therein such as confirmation of the proceedings of the last meeting, approval of the Autonomous College Budget for 2024-25, the approve of approve fee structure (UG &PG) for 2024-25, approve of the Credit Framework of the Second year UG and PG in the faculty of Humanities, Commerce & Management, Science & Technology and Professional programmes for 2024-2025, research activities carried out during 2023-24 and to approve the sport activities carried out during 2023-24. Furthermore, examination schedule and new academic programmes to be started from academic year 2024-25 was discussed.

He requested Hon'ble members to approve of the proceedings of the last meeting. The House unanimously approved the proceedings of the last meeting.

## Agenda. 1.2 To approve of the Autonomous College Budget for 2024-25

**Explanation-** It was explained by Prin. Dr. M.M. Rajmane. He told Hon'ble members that the college has been functioning as an Autonomous college from June 2019 and empowered autonomous college status by Shivaji University, Kolhapur from June 2024. The college has incurred the expenditure of Rs. **57,65,000**/ as an Autonomous college for the year 2023-24 based on the activities such as organization of Guest lectures from industry, redesigning of curricula, preparation of content, holdings meetings of Statutory bodies such as Boards of Studies, Academic Council, Finance Committee and Governing Body and further said that the college has already submitted the demand for the release of grants to UGC-WRO, Pune and the college still awaits the receipt of the same.

Then he presented before the house the Income & Expenditure sheet for 2023-24 and elaborated on the expenditure incurred on various heads during the year and brought to the notice of the house that the college has incurred the expenditure of Rs. 57,65,000/ from the college fund. Further, he said that the college has submitted demand of release of Autonomous Grant of Rs. 20 lac to UGC WRO Pune for the last Three years and hoped to get it soon. The sheet as followed.
