Proceedings of the Fourth Meeting of IQAC 2025-26 held on 25/8/2025

4.1 Confirmation of the proceedings of the Last Meeting:

Proposed by: Prof. Dr. G.B. Kalyanshetti

He read out the minutes of the Fourth IQAC meeting for the year 2024-25 held on 22nd April 2025. He elaborated on following issues of Agenda considered therein such as confirmation of the proceedings of the third meeting, approval of Action Taken Report for 2024-25, the plan of Action for 2025-26, review Research Activities, approval of IQAC Quality Initiatives, the plan for AQAR 2024-25, a review various Audits for 2024-25 & NAAC Proposed A&A Framework.

He told the house that all the resolutions made in the last meeting have been complied with by undertaking necessary steps.

He requested all the members to approve of it.

All the members approved the proceedings of the third IQAC meeting.

The same is approved and resolved.

1.2 NAAC Revised Accreditation Process

Proposed by: Prof. Dr. G.B. Kalyanshetti

He presented the issue of the NAAC Revamped Accreditation process referring to the [News Paper Note](#) published in Indian Express dated **21st July 2025**. He told the house that NAAC has introduced fully digital, simplified accreditation system for colleges, universities and the

revamped the accreditation process will be taken online. Further, he told that colleges and Universities will only receive intimation on whether they have been given accreditation or not and No seven-scale rating system that had existed the last three decades. The official announcement was made on July 29 by Prime Minister Narendra Modi. He told the house that according to the Chairman of the Executive Council of NAAC, Anil Sahasrabudhe, "As on date, roughly 40% of the 1,170 universities in the country have obtained accreditation. When it comes to colleges, not even 20% of the 50,000-odd colleges have managed to get it. He said that NAAC objective is to ensure that between 90%-95% of these higher educational institutions obtain the accreditation."

He requested all the members to approve of the issue.

Then he elaborated on the revamped process stating that earlier Accreditation was for a five-year period and the revamped process will be of just three years. "The basic process of accreditation will be fully online with no field visits. This is a major step in simplifying the process. After the basic accreditation, a new system of gradation will be introduced signaling Maturity-Based Graded Accreditation with five levels : Level 1 and Level 5. Colleges and universities upgrade one level after another. Level-1 and Level-2 are relatively easy & carried online. Level-3 will be a hybrid one with online and field visits. Institutions which already offer a high standard can directly apply to a higher level rather than approach the process step by step. Level-4 and Level-5 will be extremely difficult to obtain and have stringent qualifying criteria. Only be awarded to institutions offering education on par with international standards.

To this, the Chairperson Dr. Mohan Rajmane asked the Coordinator to start the preparation for Basic Accreditation once the guidelines will be announced and about the MBGL, he asserted, the decision will be taken.

1.3 Review of Admissions

Proposed by: Dr. A.B. Mulik

He presented the issue related to the review of admissions for the year 2025-26. He told the house that the college has implemented NEP 2020 from 2025-26 (3.0) and New Credit framework for 3/4 year Degree programme has been prepared after the meetings with NEP Steering committee. Accordingly, he told, preparation of Subject Combinations, Baskets of 6 verticals are prepared by the respective Deans making provisions for Major, Open electives, Vocational skill course, Skill enhancement course, Value enhancement course, Indian Knowledge system. He told the house that the admission were started from May 2025 and reopened the college on 16th June 2025. Then he presented the admission status till date.

1.10 Autonomous status & Implementation of NEP

The Autonomous college Coordinator Dr. A.K. Patil told the house that college has an Autonomy from June 2019 and has successfully completed 6 years of Autonomy. The college has attained Empowered Autonomous Status from Shivaji University in June 2024.

The college has implemented NEP (1.)) from 2022-23 as per Shivaji University Kolhapur guidelines, NEP 2.0 from 2023-24 as per Government of Maharashtra and NEP 3.0 from 2024-25 as per the SUK directives. He further said that respective Deans have prepared Credit Framework and syllabi framed in sub Committees and BoS of respective departments.
