Minutes of the first Governing Body Meeting held on 18/7/2022

Agenda. 2.1. To confirm the minutes of the last meeting

Explanation: Dr. M.M. Rajmane, Principal & Ex Officio read the proceedings agendum-wise of the Last Online Governing Body meeting held on 20th January 2022 at 11.30 am and brought to the notice of the house that the resolutions made therein have been executed during the first half of the year.
