The Meeting started with words of welcome and introduction of all members by Dr. S. R. Sawant.

Leave of Absence

Hon'ble Dr. Shivajirao Kadam and Dr. C.J. Khilare have telephonically conveyed their inability to attend the meeting due to certain genuine reasons. The members approved their absence. Nine (09) out of Eleven (11) members were present. Hence, the quorum was fulfilled and the meeting started.

Minutes of the first Governing Body Meeting held on 15/4/2021

Agenda. 1. To confirm the minutes of the First meeting

Explanation: The Coordinator of Autonomous college, Dr. G.B. Kalyanshetti read the proceedings agendum-wise of the First Governing Body meeting held on 4th November 2020 and brought to the notice of the house that the resolutions made therein have been executed during the year. He elaborated on the issues considered therein such as confirmation of the minutes of the Last meeting, approval of UGC Autonomous College Budget for the year 2020-21, approval of the Fee structure (UG& PG) for 2020-21, approval of the rules for Admissions from other Autonomous, other colleges from the same university and other Universities, approval of the rules for Equivalence, approval of the expenditure incurred on RUSA Research Projects-Phase II, approval of the revised curricula, Exam pattern, credits of the Second year UG and PG programmes & Diploma course under Dual Programme , approval of the Academic Calendar for 2020-21, approval of the AQAR for 2019-20, Online Teaching, approval of the decisions taken by CDC and the approval of the decisions taken by Examination Cell.

He requested Hon'ble members to approve of the proceedings of the First meeting. The House unanimously approved the proceedings by raising their hands.

Resolution: The same is resolved.

Agenda. 2. To approve of the expenditure incurred of UGC Autonomous College Budget 2020-21

Explanation- It was explained by Autonomous College Coordinator. He told Hon'ble members that the college has been functioning as an Autonomous college from June 2019. The college has prepared the Autonomous college Budget for the year 2020-21 based on the proposed activities such as organization of Guest lectures from industry,

redesigning of curricula, preparation of content, holdings meetings of Statutory bodies such as Boards of Studies, Academic Council, Finance Committee and Governing Body and further said that the college has already submitted the demand for the release of grants to UGC-WRO, Pune and the college still awaits the receipt of the same.

Then he presented before the house the expenditure incurred on various heads during the year and brought to the notice of the house that Rs.804788/ have been spent as the budgeted amount under Examinations could not be spent since the college has conducted online examinations as per the guidelines of the Shivaji University, Kolhapur. The Autonomous college Coordinator urged the members to approve the expenditure incurred against the Autonomous college Budget for the year 2020-21. The member Secretary told the members that due to COVID, the academic year is extended and hence the college will expediate the expenditure till August 2021.

The House unanimously approved the Autonomous college Budget by raising their hands.

Resolution- Expenditure of Rs.8,04,788/- till date against the Autonomous College Budget has been approved and resolved.

The same is resolved.

Agenda 2. To approve of the expenditure incurred on RUSA Activities during the year

Explanation- Autonomous College Coordinator told Hon'ble members that the college is a RUSA beneficiary of Component 8 and availed the RUSA grant of Rs. 2.5 Cr. He further told the house that under RUSA ,the college has spent Rs.1,46,16,299/- on the following items from **June 2020 to March 2021**.

Agenda 4. To approve the revised curricula, Exam pattern, credits of the Third year UG & Advanced Diploma course under Dual Programme

Explanation- Autonomous College Coordinator presented before the house the preparation of the curricula of the third year U.G. as well as Advanced Diploma under Dual programme. He told that there are 6 Autonomous colleges in the Sanstha. As per the directives given by Hon'ble Dr. Anil Patil, there has been a policy of Integrated Curricula in all the Autonomous colleges run by the Rayat Shikshan Sanstha, Satara. Accordingly, he said, the college has prepared the curricula in association with Shivaji College, Satara regarding curricula of B.A. III, D.G. College of Commerce, Satara for B.Com. III, B.Com IT III & B.C.A. III, and Y.C. Institute of Science, Satara for B.Sc. III B. Sc. Computer Sci. Entire III.

In the context of preparation of Curricula for Advanced Diploma under Dual Programme, the faculty members have prepared the curricula of their respective skill course under Advanced Diploma by seeking feedback from the industry personnel. He told the house that the curricula for U.G. & Advanced Diploma under Dual programe were approved in meetings of Sub Committees, Boards of Studies and Academic Council. He requested the members to approve of the same.

Resolution- The members approved the aforesaid and unanimously approved the curricula of the Third year UG and Advanced Diploma from June 2021.
