Proceedings of the Fourth Meeting of IQAC 2020-21 held on 24/5/2021

Leave of Absence: NIL

4.1 Confirmation of the proceedings of the Third Meeting :

The Coordinator, Dr. G.B. Kalyanshetti read out the minutes of the Third IQAC meeting for the year 2020-21 held online on 12th February 2021. He elaborated on following issues of Agenda considered therein such as the Confirmation of the proceedings of the Second Meeting, Review of Online Teaching, Reopening of colleges, Semester End Examinations and Continuous Comprehensive Evaluation of I & III Semesters of UG and PG programmes, Preparation of Annual Quality Assurance Report for the year 2019-20, Workshop on IPR, Installation of Virtual Lab etc.

Hon'ble Adv. Ravindra Pawar asked the Coordinator about the Online teaching and urged all the members to standardize the online teaching methodologies by using latest technology and asserted that the online teaching needs to be sustained since it is going to be an inseparable aspect in the next couple of years.

The Coordinator asked all the members to approve of it.

All the members approved the proceedings of the Third IQAC meeting by raising their hands.

The same is approved and resolved.

4.2 Review of AQAR for the year 2019-20:

The Coordinator told the house that IQAC has been particular about the compilation of the data of the college pertaining to NAAC AQAR and told the house that the issues have been considered, discussed in all the three meetings of IQAC and asserted that under the guidance of the Chairperson, the IQAC has successfully submitted the AQAR on NAAC portal on 3rd May 2021 and told the house that it has been approved by the NAAC by 5th May 2021. The Coordinator extended his sense of thankfulness to all the members of IQAC, the Coordinators of NAAC SSR, all the Heads of Departments, all the teaching and Administrative staff of the college for extending cooperation regarding the same.

The Chairperson and Adv. Ravindra Pawar congratulated the IQAC team for the successful submission of AQAR 2019-20.

The Coordinator requested all the members to approve of it.

All the members approved of the aforesaid issue by raising their hands.

The same is approved and resolved.

4.3 Review of IQAC Activities during the year:

The issue of Review of IQAC activities for the year was taken up. The Coordinator told the house that the IQAC has been functional carrying out academic and research oriented activities despite the pandemic and he elaborated on the IQAC activities such as Academic Autonomy under which the IQAC affirmed the conduct of 2 meetings of Subcommittees and Boards of studies in 24 disciplines regarding the revision of curricula for the Third year UG as well as of Advanced Diploma under Dual Programme, 2 meetings of Finance Committee, 2 meetings of Academic Council, 2 meetings of Governing Body and several meetings of Board of Examinations and Evaluation. Further, he outlined the completion of activities such as organization of Entrance Examination for M.Sc. Part I at Satara, Kolhapur, Vita districts in Sept. 2020, Revision of Examination pattern and adopted SEE and CCE 60+40 pattern, organization of 100 % Online lectures and Installation of Lecture Capturing System through which more than 500 lectures have been captured. He told the house that the work of the installation of Professional Studio is in progress. Further he outlined the activities conducted such as Compliances of NAAC Recommendations, Submission of AQAR 2019 -20 to NAAC, RUSA Activities, Organization

of 3 Online International Conferences and 24 National level webinars, ICT enabled Teaching, Organisation of Workshop on IPR on 18th Feb. 2021, UGC-PARAMARSHA activity in the name of 1 National level workshop in collaboration in Krishna Mahavidyala Rethare BK, RUSA sanctioned Research Proposals, Academic and Administrative Audit, Green Audit, Gender Audit, Power Audit, Registering and submitting data for ranking surveys, Preparation of Academic Calendar and Feedback from stakeholders. He further focused on the research activities under RUSA and presented before the house the following .

All the members approved the aforesaid issue by raising their hands.

4.4 Review of UGC-PARAMARSHA Scheme:

The Coordinator presented before the house the issue of UGC PARAMARSHA scheme and told the house that the IQAC has successfully implemented the scheme by organizing 5 National level seminars and Guest lectures at the places of Mentee colleges from Jan 2020 to 15th March 2020. He said, due to pandemic, the IQAC found it difficult to conduct the events during the year. However, he said that under UGC- PARAMARSHA, the IQAC has organized a 5 day National workshop on Agrobusiness Opportunities in Bio

Sciences in collaboration with the Mentee Krishna College, Rethare from 5th Feb 2021 to 10th Feb 2021.

The Chairperson asked the Coordinator to plan for the activities from June 2021 and asked him to assure the organization of at least one event a month in the next academic year. The Coordinator assured the house that IQAC will plan and organize the same in the next academic year.

The Coordinator asked all the members to approve of it.

All the members approved the aforesaid issue by raising their hands.

4.5 AQAR 2020-21

The Coordinator told the house that NAAC has issued regarding the pending AQARs and said that it has extended the date to 31st August 2021 for all the HEIs to submit their pending AQARs. The coordinator told the house that the college has submitted all its AQARs till date and told that the deadline for the submission of AQAR for 2020-21 is 31st December 2021. The Chairperson asked the coordinator to plan for the same and ensure the submission in the stipulated time as prescribed by NAAC.

The coordinator assured the house that IQAC is planning for the same and asserted that with the cooperation all the fraternity, the AQAR for 2020-21 will be submitted to NAAC office in the stipulated time.

The Coordinator asked all the members to approve of it.

All the members approved the aforesaid issue by raising their hands.

4.6 Action Plan for 2021-2022:

The Coordinator of IQAC told the House that the IQAC has prepared the Action plan of the college for the next academic year i.e. 2021-22 in consultation with the Heads of Departments under the guidance of the Chairperson and asserted that the college plans to initiate a programmes such as B.Com. in Bank Management, Agriculture programme under B.Voc., Industrial Management as specialisation at B.Com. Part III, additional Division for B.Com. IT and a Certificate Course in Yoga Therapy and Meditation.

Adv. Ravindra Pawar asked the coordinator to include the pranayama in the Course on Yoga Therapy since it is quite important in the pretext of pandemic.

The Coordinator asked all the members to approve of the plan for 2021-22.

All the members approved the aforesaid issue by raising their hands.

4.7 Any other Issue with the permission of the Chair:

The issue of Online Teaching to the UG & PG classes was taken up and the Chairperson asked the House that the all Heads of the Departments should take measures for effective delivery of the contents via online teaching.

Another Issue of organisation of meetings of Boards of Studies was taken up by the IQAC Coordinator and requested the Chairpersons of respective BoS to organize at least 2 BoS meetings in their respective disciplines during the year as per the UGC guidelines and requested the Heads to include the same in the Annual plan of the department that is normally prepared at the commencement of academic year and asked them to ensure the holding of the meetings.

The Coordinator asked all the members to approve of it.

All the members approved the aforesaid issue by raising their hands.

Since there was on other matter left, the meeting was concluded with the proposal of vote of thanks by the Registrar Shri. R.Y. Gaikwad.
